CHIEF BYRNES' REPORT – No Report

Lt. Schoch discussed the issue of the furnace breaking and no co alarms being present in that area. Commissioners authorize Lt. Schoch to get three CO alarms for the gym, conference room and main station office.

Lt. Schoch advises that the magic jack is just not working up at the main station. He will look into getting prices for a new line up there for the office.

Lt. Schoch advises that since there are no labor management meetings lately, he needs to address the fact that the Siren is going off again during the day. President Hussey will check into this matter.

CHIEF FATOVIC'S REPORT – A report has been given to the Commissioners for review. A copy of report is attached.

Discussion regarding radios, signals and dispatching. The Board is advised that there are three options: Scrapping the system to new system based off Pd system; going to our own digital system and third putting tower by Whitesville firehouse. Need to do feasibility to see what is the best model, not cheapest. Crystal brook. Stop and shop, brookwood 3, brookwood parkway has no signal no matter what. Assist Chief Carson advises that e dispatch is a back up for now. He will be getting together with Ken to set up recall notices, etc.

Board is advised that there is one injury at the last fire, past chief masker. Everything is being processed and he will need work. The insurance company will advise.

Chief Fatovic discussion regarding plowing. He'd like to see about possibly putting a plow on one of the vehicles. There is a gentleman from Cassville will is selling the plow. Paid \$5,000 asking \$2,000. Will come with formal proposal.
